- KNCT will provide one 6' table as well as two (2) complimentary guest tickets. Additional tickets may be purchased.
- Two wine glasses, one rinse bucket and water pitcher provided for each table. Vendor must provide its own cooler. Ice is available at no charge at Killeen Civic and Conference Center.
- KNCT will provide a tablecloth for each table. Vendor may bring its own table cloth, skirting, table banners, decorations, promotional materials, etc. Vendor is free to decorate table, with final approval by KNCT of all such decorations etc. Tasting glasses will be provided by KNCT to all attendees.
- Vendor's name, address, logo and description of wine list will be printed in the program book. **Wine list due by April 15, 2017**, please email to Pat.McCray@KNCT.org
- You will receive a listing and link on the KNCT web site.
- Set up June 3rd between 1:00 pm and 4:30 pm at the Killeen Civic and Conference Center, 3601 S. WS Young Drive, Killeen, TX. All vendors must be at their tables by 6:30pm.
 - Vendor must provide at least (3) different wines, two (2) bottles each, for sampling. All wine will be invoiced at wholesale price through Killeen Civic & Conference Center and delivered on or before 6/2/17. Email your invoice to Kathie Mulheron KMulheron@killeentexas.gov
No wine may be taken out of the ballroom once opened.

All attendees MUST BE 21 OR OVER. No person under 21 will be admitted. Photo ID will be required.

Attendees will receive a wristband that anyone pouring should check before serving. If vendor suspects attendee is not 21 or over, vendor must not serve that individual per TABC regulations and is obligated to contact event officials.

RELEASE AND ASSUMPTION OF RISK
